

## CONSENT TO THE PROCESSING OF PERSONAL DATA OF CLIENTS - NATURAL PERSONS

The user making the request on the website <https://phoenix-cg.ru> adopts this Consent to the processing of personal data (hereinafter Consent). Acting freely, of their own free will and in their interest, as well as Reaffirming its capacity, the User agrees that the Individual entrepreneur Malygin Ignat Y. (INN 667115371697, CERTIFICATE: 66 number 007789117 from 17 Feb 2015), which is located at the address: 620146, Sverdlovsk region, Ekaterinburg, Amundsena str., building 57, room 3, to the processing of personal data by the following terms:

1. The Consent is given to the processing of personal data without using automation tools and their use.
2. Consent is given to the processing of my personal data:

Personal data that is not special or biometric: contact telephone numbers; email address; place of employment and position held; user data (location; type and OS version; the type and version of Browser; the type of device and resolution of its screen; the source from which came the website the user; with a website and some advertising; the language of the operating system and Browser, and what page opens on which buttons the user clicks; ip address).

3. Personal data are not publicly available.
4. The purpose of the processing of personal data: processing of incoming requests individuals to provide consulting; analyst actions individuals web site and operation of the website; conducting advertising and newsletters.
5. The basis for the processing of personal data is article 24 of the Constitution of the Russian Federation; article 6 of Federal law No. 152-FZ "On personal data"; this Consent to the processing of personal data.
6. In the course of processing personal data will be carried out the following steps: collecting; recording; systematization; accumulation; retention; clarification (updating, change); retrieval; use; blocking, deletion, destruction.
7. Personal data are processed to unsubscribe individuals from advertising and newsletters. Also, the processing of personal data may be terminated at the request of the data subject. Storage of personal data recorded on paper is carried out in accordance with Federal law No. 125-FZ "About archival business in the Russian Federation" and other regulatory legal acts in the field of archiving and archival storage.
8. Consent may be withdrawn by the personal data subject or his representative by sending a written application of the Individual entrepreneur Malygin Ignat Y. or his representative at the address stated at the beginning of this Agreement.
9. In case of revocation the personal data subject or his representative consent to the processing of personal data by the Individual businessman Malygin Ignat'evich may proceed with personal data processing without consent of personal data subject if there are grounds specified in clauses 2 – 11 of part 1 of article part 2 of article 10 and paragraph 2 of article 11 of the Federal law №152-FZ "On personal data" dated 27.07.2006 G.

10. This consent is valid at all times until the termination of personal data processing specified in clause 7 and clause 8 of this Agreement.
